## CORSHAM CEMETERY – TABLE OF FEES 2009/2010 (EFFECTIVE FROM 1 APRIL 2009)

*The Fees and other charges set out below apply:*

- where the person to be interred was, at the time of their death, a parishioner of the Parish of Corsham;
- where the person to whom a right is granted is such a parishioner;
- in the case of a still born child, where one of the parents is such a parishioner.

In all other cases the fees and other charges will be doubled, except where the Exclusive Right of Burial in the grave in question or the right of constructing the walled grave or vault was purchased at the single rate.

(c)	of the body of a person whose age at the time of death exceeded 16 years.	£400.00
(d)	of the cremated remains of a person whose age at the time of death exceeded 16 years.	£145.00

<b>1B</b>	<b><i>For the interment in a grave (in the lawned area – no kerbing) including Grave Digging</i></b>	
(a)	of the body of a still born child or of a child whose age at the time of death did not exceed twelve months or of the cremated remains thereof.	FREE (non-parishioners £60.00)
(b)	of the body of a child whose age at the time of death exceeded twelve months but did not exceed 16 years or of the cremated remains thereof.	£60.00
(c)	of the body of a person whose age at the time of death exceeds 16 years.	£365.00
(d)	of the cremated remains of a person whose age at the time of death exceeded 16 years	£125.00
(e)	walled grave or vault	at cost

	(b) for the right to erect on an earthen grave in respect of which the Exclusive Rights of Burial has been granted, a headstone with first inscription (in the lawned area – no kerbs)	£65.00 + VAT
	(c) for each subsequent inscription	£40.00 + VAT
