- 16. Former Family Health Centre, Beechfield Road, Corsham (Minutes 201/22 and 173/22) Further to previous Council meetings, a meeting with the Integrated Care Board (ICB) is being arranged via Cllr Crockford and The Rt Hon Michelle Donelan MP. The ICB's Place Director, Fiona Slevin-Brown has also been contacted, via Wiltshire Council, for an update. There have been several suggestions for potential use of the former Family Health Centre which can be discussed once the ICB has reached a decision on the future of the property for information and comment.
- 17. Parking Charges for Blue Badge Holders (*Minute 202/22*) Further to the previous meeting, the Chief Executive and Vice-Chair met Wiltshire Council's Parking Services Manager to discuss trying to remove the requirement for Blue Badge holders to display a pay and display ticket for the first three hours parking. Agreement to trial this for a three-month period has been reached, subject to Cabinet Member approval. If approved, the trial would be reviewed with the hope that it would be made permanent. There is no additional charge to the Town Council for the trial for consideration.
- 18. The Future of Visit Wiltshire The Town Council has been approached by the Chairman and Chief Executive of Visit Wiltshire concerning Wiltshire Council's future funding of the organisation. The Town Council is a member of Visit Wiltshire. The attached report by the Head of Community Services explains the situation and

potential impact on Corsham's visitor economy. The report recommends writing to the Leader of Wiltshire Council in support of Visit Wiltshire's request regarding funding – *for consideration.*
