- 14. Proposed Temporary Footpath Closure, The Batters, Corsham from 17 to 28 August 2020 (Minute 142/19) Further to the Council meeting on 14 October 2019, Wessex Water in planning to continue its essential sewerage works in Corsham. This requires temporarily closing The Cleeve footpath, parts of Cleevedale Road and Lypiatt Road and the footpath through The Batters, which is owned by the Town Council (see attached plans).
 - Wiltshire Council has approved the plan to close Public Right of Way CORM11;
 - Road and footpath closures have been approved by Wiltshire Council. Advanced Warning Road Signs are due to be installed during week commencing 10 August;
 - Letters have been posted out to local residents to inform them of the works and closures, and to offer a taxi service for affected residents close to the railway pedestrian bridge (see attached);
 - A notice has been installed for a section of footpath with an unknown owner to meet the statutory notification requirements.

The Chief Executive has visited the site with Wessex Water to help plan the works through The Batters and agreed a number of conditions for accessing and using the site. Wessex Water is happy to hold a Teams meeting with the Town Council if required – *for information and comment.*
