Swindon and Wiltshire Rail Study – Systra has recently been appointed by Swindon and Wiltshire Local Enterprise Partnership (SWLEP), Wiltshire Council and Swindon Borough Council to provide an evidence base and develop a strategy to inform and support SWLEP's approach to investment in the rail network. This will inform and guide both Swindon Borough Council and Wiltshire Council's Local Plan and Local Transport Plan with the aim of economic and social development up to 2036 (*see attached letter*). The research includes a survey regarding rail developments and improvements such as new stations. The information will be used to inform an initial set of options to be assessed within the study. The Chairman of the Corsham Station Town Team has prepared a draft response for consideration (*copy attached*). The Town Council is asked to consider the draft response and put forward any further suggestions it may wish to include for improving the rail network – *for consideration*.
