- 13. Corsham Youth Council 2020/21 To consider how Corsham Youth Council may operate during the new academic year. It is suggested that the Town Council asks the local school councils to consider any matters that would normally have been discussed by CYC, and that the school councils are also encouraged to submit their own matters for consideration until such time as face to face meetings can be held. The Head of Community Services has contacted the primary schools for their advice on how CYC may run this year, and their reaction to this suggestion. She will also be contacting The Corsham School for their feedback. If there is enough interest in the Town Council linking to the school councils, then HoCS will co-ordinate requests and responses so they can be referred to the Council or Committee as appropriate for consideration.
- 14. The Future of Neighbourhood Planning in Wiltshire Further to the recent issues raised by Malmesbury Town Council and the subsequent meetings which the Chairman took part in as Chair of the Corsham Neighbourhood Plan Delivery and Monitoring Group, a letter to MP's and a press release about the matter are attached for information and comment *for information.*
- 15. Issues for Corsham Area Board Consideration (*Various minutes*) Further to previous meetings, this regular agenda item asks the Town Council to identify issues for Area Board consideration *suggested issues invited*.
- 16. Authorisation of cheques and payments A list will be available at the meeting. It is recommended that an additional grant of £5,736.60 + VAT be made from the Town Council to the Methuen Hall for the cost of energy efficiency improvements (new lighting). This can be funded from the earmarked reserve for Environmental Projects (EMR 353) which has a balance of £7,715 for approval.

- 17. Covid-19 Emergency Update, Recovery Plan and Q&A Updates include:
 - Grant The Town Council has received a small business grant of £10,000 towards Covid-19 costs;
 - Car Parking Initial data has been received from Wiltshire Council re twohours' free parking. It is too early to tell how successful the scheme is;
 - Business Survey To be addressed over the next month or two;
 - Recovery Plan The Plan has been updated. A further update will be made by the end of September when the volunteering aspects have been discussed. The Plan will then be published online;
 - Emerging recovery data from Wiltshire Council.

The Methuen (Town) Hall meeting will take place immediately after the Council meeting.
