The SID has recorded excessive speeds on a number of occasions and the police have been asked to carry out patrols. Councillors are asked to consider what other measures could be explored to help tackle the problem for discussion.

Since the list was agreed, delays in Wiltshire Council's SDAT programme have enabled the Town Council to utilise some of the funds for other related activities including: purchase of an electric vehicle; a licence for land at Park Lane/Bath Road for the stone trolleys, and tree felling at the Chapel Cemetery in Ladbrook Lane. Discussions have also taken place about land at Moor Park, Neston and South Street. A top up street sweeping service has been introduced on a trial basis, using an outside contractor and the provision of recycling bins in the Town Centre has been approved by the Full Council. Also, the Head of Technical Services is exploring environmentally friendly weed control measures for roads and pavements. Further information will be available at the meeting – for discussion.
