

The Town Council exists to improve the economic, social and environmental well-being of Corsham.

The Council provides leadership through community governance and engagement in a democratic and representational way.

#### A Vision for Corsham

The Town Council's vision for Corsham for 2022-2026 is 'An engaged community - making life better in Corsham through equality, accessibility and inclusivity'.

A guiding principle of delivering this vision is the strong desire to create an engaged, sustainable community which balances environmental, social, cultural and economic needs.

#### There are four overall strategic themes:

- Environment and Climate Change Minimising the town's impact on climate change and protecting our natural environment
- Transport and Highways- Implementing a sustainable Transport Plan
- Business and the Economy Ensuring a thriving and successful town centre and supporting local businesses
- Community Wellbeing Supporting local interest groups and delivering targeted activities to improve health and wellbeing

At the heart of the Strategic Plan is community engagement and we want to improve our engagement with people and groups in our community. We plan to open up new ways of getting a clearer understanding of the concerns and priorities of those who live and work here so that we improve our decision-making and allocation of resources. We are always open to approaches from individuals or groups who have something to say.

# Corsham Town Council - Chairman's Annual Report

This report was given at the Corsham Celebrates event, incorporating the Annual Town Meeting, held at the Town Hall on 20 April 2023.

Town Council Chairman, Cllr Steve Abbott's report on the Council's year from May 2022-April 2023.

It has been a difficult year in a number of ways, with Covid still affecting everybody's lives, and also the impact of the death of Queen Elizabeth, our Queen for over 70 years, but the work of the Town Council cannot stop and I would like to give you a quick rundown of our achievements over the last year as well as our ongoing projects that have been worked on but have not yet come to fruition.

The projects first:

#### **Corsham Railway Station**

We wait to hear whether our bid to get to the next stage of the new station's programme has been successful - a decision is expected in June or July.

#### **Corsham Town Council Workshop**

We are disappointed that Wiltshire Council has not yet made a decision on our planning application for a new eco-friendly workshop for our Grounds Staff. This is a proposal that will have significant, positive knock-on effects for the Council. A decision is expected in the next few weeks.

#### Public Realm

We are still working up detailed proposals for improvements on Newlands Road to improve the street scene for the benefit of visitors to the town centre, particularly pedestrians and cyclists.

#### 20mph Speed Limits

Newlands Road is also part of our proposed area for 20mph speed limits in town. The 20mph restrictions in Neston have been agreed by Wiltshire Council Highways and will hopefully be initiated in the summer/autumn/

In November 2022, the Town Council approved its Strategic Plan for 2022-2026, giving us four main themes for our work. These are Environment and Climate Change, Community Wellbeing, Transport and Highways and Business and the Economy. The over-arching priority for the whole Plan is Community Engagement. As well as creating a new Community Engagement Strategy, EasyRead versions have been produced allowing us to share the Strategic Plan and Community Engagement Strategy with those who find reading more difficult.

#### **Environment and Climate Change**

- We have a Climate Change Action Plan to help with our aim to be operationally carbon net zero by 2030. This also includes
  making our buildings net zero too.
- Our Biodiversity Action Plan will be published imminently and will help us change the way in which we manage many of our sites around town, including Springfield Rec and Beechfield Wildlife Area.
- We held our first Eco Fair with the second due to take place on 22 April.

#### **Community Wellbeing**

- We have helped to increase youth activities by supporting and funding Corsham Youth Zone and the outreach youth work undertaken for us by The Rise Trust. We are also supporting The Rise Trust with their work with local families and under-5s.
- The Town Council has taken on five play areas from Wiltshire Council: two at Katherine Park, two on Pockeridge Road and the
  one at Bences Lane.
- We have given grants to 20 local groups and organisations in the last financial year.
- We have supported community arts projects, including one currently being undertaken in the Potley/Portland Rise area.

#### Transport and Highways

- We have improved those local bus stops for which we are responsible.
- We are working on road safety initiatives around the town, including 20mph limits
- We have improved the Cycle Network with the resurfacing along Pockeredge Drive.
- Work has started on our new Transport Plan.

#### **Business and Economy**

- The Town Council's new, full-time Community Services Officer (Tourism and Events) also has a remit to work with our local businesses.
- We continue to fund two hours' free parking, which has helped draw people to the town centre.
- Our town events programme of the Eco Fair, Taste of Corsham, the Summer Fete, Street Fair and Christmas Lights Switch-On continues, with the events getting bigger and better each time.
- We have instigated new, regular 'Business Forum' events at Digital Mansion Corsham.
- The Town Council has trialed an increased level of street cleaning, and also took on a new, part-time street cleaner/litter picker to work around the town centre and at other locations.

#### **Community Engagement**

- We are finding better ways to connect with individuals and community groups to help us hear people's views.
- We are working with Bath Spa University's We Are the People project to create a Disabled People's Organisation (DPO), which will help us to respond to the needs of disabled people in Corsham.
- We continue with our regular liaison meetings with The Corsham School, MOD Corsham, Bath Spa University and our local sports clubs via our Sports Forum.

I would like to say thank you to my fellow Councillors for all their work this year and also to David Martin, the Town Council's Chief Executive, and the staff for helping us deliver our plans.

## Grants Scheme 2022/23

#### Grants

Twenty grants were awarded during the 2022/23 financial year, reflecting the ongoing difficulties caused by the pandemic which meant that many groups and organisations were still unable to meet and thus did not need to approach the Town Council for funds.

#### APPLYING FOR A GRANT

The Town Council runs its own Grants Scheme awarding sums of money up to £750 (from April 2023) to community organisations working to benefit residents by improving the range of activities and services within Corsham.

Each application is considered at the Town Council's Finance and Administration Committee's meetings which take place in February, April, June, August, October and December.

Projects for young people and community wellbeing projects can apply for £751-£2,000 and these applications are considered by the Community Services Committee at their meetings in January, March, May, July, September and November.

Grants can be awarded to new, as well as existing groups and there are no restrictions on whether the funds are for a capital or revenue project, but the organisation applying must be not-for-profit or charitable and grants will not be made to individuals.

In exceptional circumstances, such as large capital projects, grants over these sums can be awarded. The Town Council must be notified of such requests by September so that funds can be earmarked in the following year's budget.
