**TABLE OF FEES 2023/2024 (EFFECTIVE FROM 1 APRIL 2023)**

***The Fees and other charges set out below apply:***

- where the person to be interred was, at the time of their death, a parishioner of the Parish of Corsham; or had been moved to a care home outside of the parish within two years prior to the date of death, the fee will remain at the standard rate;
- where the person to whom a right is granted is such a parishioner;
- in the case of a stillborn child, where one of the parents is such a parishioner.

**In all other cases the fees and other charges will be doubled, except where the Exclusive Right of Burial for the grave in question was purchased at the single rate.**

The Childrens Funeral Fund was introduced in July 2019. The family is not charged for the burials as the cost is reclaimed from the Children's Funeral Fund for England. Previously the Town Council charged ages 1-16 years.
